<b>Registration Fee:</b> \$30 (Due once per summer, per camper. Not eligible for discounts.)
<b>General Tuition Rate:</b> \$525 per 2-week session <b>CA Resident Rate:</b> \$480 per 2-week session Those who live or work on Columbia Association assessed property (properties subject to the CA annual fee, also known as lien or CPRA) receive a reduced rate.
<b>Pay-in-full Discount:</b> Receive \$100 off each session's camp tuition when you pay-in-full before April 15, 2020. (Applicable to camp tuition only - cannot be combined with any other offer.)
<b>Extended Camp Fees:</b> (Not eligible for discounts.) <b>Before Care - \$40 per week, After Care - \$45 per week, Both - \$80 per week</b>
A minimum payment of \$150 per session is required at the time of registration to reserve a camper's spot. This \$150 dollars is non-refundable as it is considered a deposit that is applied toward tuition.
